MAORI 200 : Kaupapa Hōu: Special Topic: Māori Health and Wellbeing

2024 Semester One (1243) (15 POINTS)

Course Prescription

Draws on critical and ecological approaches to examine Māori health and its contribution to understanding the challenges and impacts of poverty, inequality, racism, discrimination, privilege and power for Māori health across Aotearoa. This course covers topics relevant to students who wish to draw upon Māori health in applied settings and research whilst working responsibly with Māori and other indigenous peoples.

Course Overview

This course will examine important conceptual frameworks and theory within Māori health. Māori perspectives and exemplars will be a significant emphasis within the course. This course draws on critical and ecological approaches to examine Māori health and its contribution to understanding the challenges and impacts of poverty, inequality, racism, discrimination, privilege and power for Māori health across Aotearoa. This course will cover topics relevant to students who wish to draw upon Māori health in applied settings and research whilst working responsibly with Maori and other indigenous peoples.

- 4. Demonstrate an understanding of minority group perspectives of Aotearoa and how this might influence their work as health practitioners (Capability 1, 3, 4, 5, 6 and 7)
